**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
RECOMMENDING APPROVAL**

RESOLUTION No. 2014-086

WHEREAS, the Road Board posted an Invitation to Bid on March 3, 2014 at the PhilGEPS website for the Supply and Delivery of Monitoring Equipment with an Approved Budget for the Contract of Twenty-Three Million Eight Hundred Forty Thousand Pesos (Php23,840,000);

WHEREAS, the same invitation was advertised in the March 3, 2014 issue of the Philippine Daily Inquirer;

WHEREAS, in response to the said advertisements, four (4) prospective bidders submitted Letters of Intent (LOIs) and three (3) submitted their Bids;

WHEREAS, during the Opening and Preliminary Evaluation of Bids on March 24, 2014, two (2) bidders were disqualified and only one (1) bid was opened;

WHEREAS, after examination, validation, and verification of the eligibility requirements submitted by the bidder on April 4, 2014, the following results were obtained:

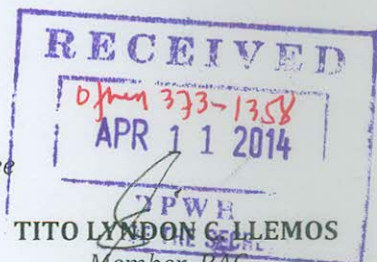
