

CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

THE PARTIES:

The **ROAD BOARD**, a government entity established under Republic Act (R.A) 8794, with principal office at 2nd Floor Ave Maria Building, 1517 Quezon Avenue, West Triangle, Quezon City, herein represented by its Chairman, **ROGELIO L. SINGSON**, and hereinafter referred to as the "**FIRST PARTY**".

and

ALCEL CONSTRUCTION a sole proprietorship engaged in construction with address at Poblacion, Alaminos City Pangasinan, herein represented by its General Manager, **ALEXANDER M. ANG**, and hereinafter referred to as the "**SECOND PARTY**".

RECITALS:

WHEREAS, the **FIRST PARTY** desires to engage the services of an entity for the Maintenance of National Roads and Bridges (High Pressure Cleaning and Painting) along Taft Avenue from P. Ocampo St. to T.M. Kalaw Avenue (S02958LZ Ch. 0 to Ch. 2654).

WHEREAS, the **SECOND PARTY** has represented that it is capable of performing the desired services, and has agreed to provide such services to the **FIRST PARTY**, under the following terms and conditions.

IT IS AGREED:

The following documents shall be deemed to form, and be read and construed, as part of this agreement, to wit:

- a. The complete set of bidding documents (Annex "A");
- b. Bid Bulletins (Annex "B");
- c. Bid Form including all the documents/statements contained in the Supplier's Bidding Envelopes (Annex "C");
- d. Detailed Plan Schedule (Completion of work is within ninety (90) calendar days submitted by the Supplier (Annex "D");
- e. Performance Security (Annex "E");
- f. Post Evaluation Report (Annex "F"); and
- g. Notice of Award of Contract and Supplier's "Conforme" thereto (Annex "G").



OBLIGATIONS OF THE FIRST PARTY

1. For and in consideration of the **SECOND PARTY'S** services, the **FIRST PARTY** shall pay the **SECOND PARTY** the amount of Nine Million Nine Hundred Seventy-Eight Thousand Six Hundred Ninety-Two Pesos and 53/100 (P=9,978,692.53), Philippine Currency, inclusive of VAT, payable in accordance with the terms and conditions specified in the attached documents (Annexes A to G).


OBLIGATIONS OF SECOND PARTY

1. The **SECOND PARTY** shall perform the obligations in accordance with the terms and conditions of all the documents that are appended hereto (i.e. Bid Documents, Bid Bulletins (Annexes A to G);
2. The **SECOND PARTY** shall coordinate with the **FIRST PARTY** in every stage of the required activities.
3. This agreement shall take effect on the date indicated in the Notice to Proceed that was issued by the **FIRST PARTY** in favor of the **SECOND PARTY**.




