
WHEREAS, after Evaluation, the bid amounts as read were found to be free from computational errors;




NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

KNOW ALL MEN BY THESE PRESENTS:

THE PARTIES:

The **ROAD BOARD**, a government entity established under Republic Act (R.A) 8794, with principal office at 2nd Floor Ave Maria Building, 1517 Quezon Avenue, West Triangle, Quezon City, herein represented by its Chairman, **ROGELIO L. SINGSON**, and hereinafter referred to as the "**FIRST PARTY**".

and

MINDANAO ROCK a sole proprietorship engaged in construction with address at Don Anselmo Bernad Avenue, Ozamiz City, herein represented by its Project Manager, **ERIC O. LIM**, and hereinafter referred to as the "**SECOND PARTY**".

RECITALS:





WHEREAS, the **FIRST PARTY** desires to engage the services of an entity for the Installation/Construction of Reflective Thermoplastic Stripping Materials (Solid Form) with Performance Requirements (Region XII)

WHEREAS, the **SECOND PARTY** has represented that it is capable of performing the desired services, and has agreed to provide such services to the **FIRST PARTY**; under the following terms and conditions.

IT IS AGREED:




