**BAC RESOLUTION DISQUALIFYING THE LONE BIDDER  
AND DECLARING FAILURE OF BIDDING**

**RESOLUTION No. 2014-112**

**WHEREAS**, the **Road Board** advertised the Invitation to Bid for the National Road Lighting Program *Supply and Installation of Luminaires* (Package 7) with an Approved Budget for the Contract of One Hundred Thirty-Six Million Two Hundred Twenty-Three Thousand Pesos (₱136,223,000.00) in the August 7, 2014 issue of the Philippine Star and through posting in the RB website and in the PhilGEPS during the period of August 7-13, 2014;

**WHEREAS**, in response to the said Invitation, nine (9) prospective bidders purchased and five (5) submitted bid documents;

**WHEREAS**, during the Opening and Preliminary Evaluation of Bids on September 10, 2014, four bidders were found ineligible which resulted to disqualification, while the bid of Fabmik Construction and Equipment Co., Inc. was opened;

**WHEREAS**, during Bid Evaluation, the following were ascertained;


- Test results for tabs M-A, N-A, P-A, S-A, M-B, N-B, P-B, and S-B were conducted at an ambient temperature of 25°C for 6,048 hours instead of 45°C for 10,000 hours L70 (10K);
- Lumen output values at 80° and 140° angles are 479.124 and .799 (tab R-A) and 298.961 and .395 (tab R-B) respectively instead of zero (0);
- No extracted details of materials, finishes, and weight were provided in the luminaire drawing submitted for tabs T-A and T-B; and
- Only a Certificate of Final Inspection was attached for the completed similar contract 06HO0021 amounting to ₱ 62,284,272.55 (adjusted value).


**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- To disqualify Fabmik Construction and Equipment Co., Inc.;
- To declare failure of bidding for the subject project;
- To recommend to the HOPE to re-advertise the proposed project for another bidding in accordance with Section 35 of RA 9184.
