BAC RESOLUTION DECLARING FAILURE OF BIDDING

BAC RESOLUTION No. 2015-151

WHEREAS, the Road Board posted the Procurement of Various Inks, Cartridges and Toners with an Approved Budget for the Contract of Six-Hundred Seventy-Two Thousand Four-Hundred Seventy-Five Pesos (₱ 672,475.00) through posting in the RB website and in the PhilGEPS during the period of June 2-22, 2015;

WHEREAS, in response to the said Invitation, two (2) prospective bidders purchased and two (2) submitted bid documents;

WHEREAS, during the Opening and Preliminary Examination of Bids on June 22, 2015, one (1) bidder was found non-complying which resulted to disqualification, and one (1) bid was opened;

WHEREAS, during Evaluation, bid amount was corrected and ranked as follows;

WHEREAS, after Evaluation, the Bids and Awards Committee (BAC) deemed that it would be most beneficial to the government if the cost per item be adjusted to a lower price without compromising the quality of the inks;

WHEREAS, Section 1. Invitation to Bid item number 17 of the bidding document states that "The Road Board reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a. To declare Failure of Bidding for the Procurement of Various Inks, Cartridges and Toners.
- b. To repost/re-advertise once the adjustment of quantity is finalized and the new Approved Budget for the Contract (ABC) is determined.
