BAC RESOLUTION DECLARING FAILURE OF BIDDING

BAC RESOLUTION No. 2015-160

WHEREAS, the **Road Board** advertised the Invitation to Bid for the Installation/Application/Construction of Directional Signages (Alternate Routes) within NCR with an Approved Budget for the Contract of Forty-Six Million Two Hundred Fifty-Three Thousand One Hundred Thirty Pesos and 31/100 (₱ 46,253,130.31) in the July 29, 2015 issue of the The Philippine Daily Inquirer and through posting in the RB website and in the PhilGEPS during the period of July 29-August 4, 2015;

WHEREAS, in response to the said Invitation, two (2) prospective bidders purchased and three (3) submitted bid documents;

WHEREAS, during the Opening and Preliminary Examination of Bids on August 25, 2015, two (2) bids were opened;



- a. To declare Failure of Bidding for the project Installation/Application/Construction of Directional Signages (Alternate Routes) within NCR


